Recommendations

- finalising the review of the Guiding Statements as a precursor to developing and implementing a new Strategic Plan;
- reaching consensus at a Board level in terms of extending the current lease arrangements or locating a site on which to build a new school facility;
- continuing the ongoing work in the area of teaching & learning, including but not limited to strengthening the vertical articulation of the curriculum, strengthening the transition between and across programmes, ensuring that the newly developed assessment and language policies are effectively implemented and clarifying the pedagogical leadership structure and associated responsibilities;
- ensuring the recently revised faculty appraisal tool is reviewed and modified if deemed applicable; and reviewing the staffing in the area of EAL and SEN. And, in the process, ensure that the overall level of staffing in this area is sufficient to meet current and future student needs.

PYP Commendations

- The school supports and promotes the action component of the programme.
- The school models and promotes open communication across the school community. Leaders, teachers, students and parents consistently describe a respectful learning and workplace environment.
- The school has allocated funding to facilities that enhance the implementation of the programme at the school above what is required.
- The school provides significant learning support for students within the programme.
- The school has made significant changes in the timetable to ensure it provides significant opportunity for in-depth inquiry and transdisciplinarity via the published and implemented teacher schedule.
- The school utilizes local resources and expertise to enhance teaching and learning within the primary section of the school.
- Teachers have incorporated differentiation for student learning needs and styles into collaborative planning and reflection.
- The school has significantly developed capacity in the area of differentiation, supporting individual needs, interests and learning styles and promoting a culture of student support, success and inclusivity.
- The school encourages teachers to engage a broad range of strategies supporting teaching and learning.
- The school demonstrates the use of grouping and regrouping across the school for a variety of learning purposes.
- The school has built a stimulating learning environment based on understanding and respect throughout the school community.

PYP Recommendations

Developing and completing written curriculum documents by:

- ensuring that we continue to complete consistently formatted planners that are easily accessible
- ensuring that our written curriculum is equal to or better than PYP scope and sequence documents., and that it is more readily accessible.

Improving planning and collaboration practices by:

- ensuring that we continue to explore how to collaborate more effectively when developing units within and beyond the programme of inquiry
- ensuring that our practices are more clearly aligned with our policies

Strengthening some core teaching and learning by:

- ensuring that we continue to build a shared understanding of the inquiry process
- ensuring that all of the programme's essential elements are regularly assessed.

Providing more comprehensive professional development opportunities by:

- ensuring that we continue to develop opportunities for more involvement with educators beyond the school.
- ensuring that we develop further access to current IB publications

- Encouraging and supporting students to be actively responsible for their own learning
- Meaningful reflection on service activities

MYP Recommendations

- A system for the cyclic review of the planning of ATL skills
- Ways to allow for meaningful opportunities for student service in action to arise from the written curriculum
- Interdisciplinary unit plans that strengthen cross curricular skills and deepen disciplinary understanding
- Good practice and incorporate differentiation for students learning needs and styles into collaborative planning and reflection
- The use of global contexts for inquiry based learning
- Learning experiences to support language development of students and to address the diversity of student language needs, including those for students learning in a languages/s other than their mother tongue
- Standardisation of assessment within the subject groups

DP Commendations

- Teachers' commitment to the Programme.
- Offering a significant variety of courses despite its relatively small student numbers.
- Establishing a culture of sustainable action in the local community, which sees students engaged in long-term service work,
- Creating close links with experts from the community that contribute to the development of the Programme.
- Connecting with local and international organisations and provides the students with local and international organisations and provides them with excellent support.

DP Recommendations

- Collaborative planning, with linking to other subjects and TOK, for a more contextual and conceptual learning experience
- Alignment between MYP and DP, for a smoother transition
- Inclusion of the Learner Profile, making the attributes more explicit
- System for analysing assessment data, using findings to further improve teaching and learning


